Project Overview

Crystal Clear Communications is assisting the Hawaii Broadband & Digital Equity Office — part of the Department of Business Economic Development & Tourism (DBEDT) — to develop a Digital Equity Ecosystem Map. The map will be a visual representation of the digital equity services, programs and projects that comprise the current digital equity ecosystem in Hawaii.



September 15 - October 15 2021 Project Activities

Our team kicked off the Digital Equity Ecosystem Map project with an initial meeting with Burt to discuss the goals and objectives of the project. We also met with AARP Hawaii as well as Kayla Carlisle from Hawaii Public Health Institute to support their digital roadmap for kupuna. Throughout the month, we focused our efforts on planning, developing our survey and outreach list, as well as coordinating and conducting meetings with key individuals and organizations that work in the digital equity space.

Materials Development

To prepare for the Digital Equity Ecosystem Map, our team focused on creating the following materials:

- **Action Plan:** Our team crafted a three-month action plan focused around the development of a digital equity ecosystem map that includes outreach for gathering information around Hawaii's digital equity ecosystem, visual elements for the digital equity ecosystem and more.
- **Community Outreach Survey List:** Our team put together a list of key community organizations, companies and individuals in the digital equity space to coordinate listening sessions with, to gather information on their digital equity services, programs or projects currently underway, to provide a baseline of activities spanning digital literacy, inclusion and adoption.
- **Survey Questions:** We developed survey questions to ask all participants to help determine their place in the digital equity ecosystem.
- **Map Elements:** Our team developed an initial draft design for the ecosystem map and how to incorporate Hawaii graphics / elements.

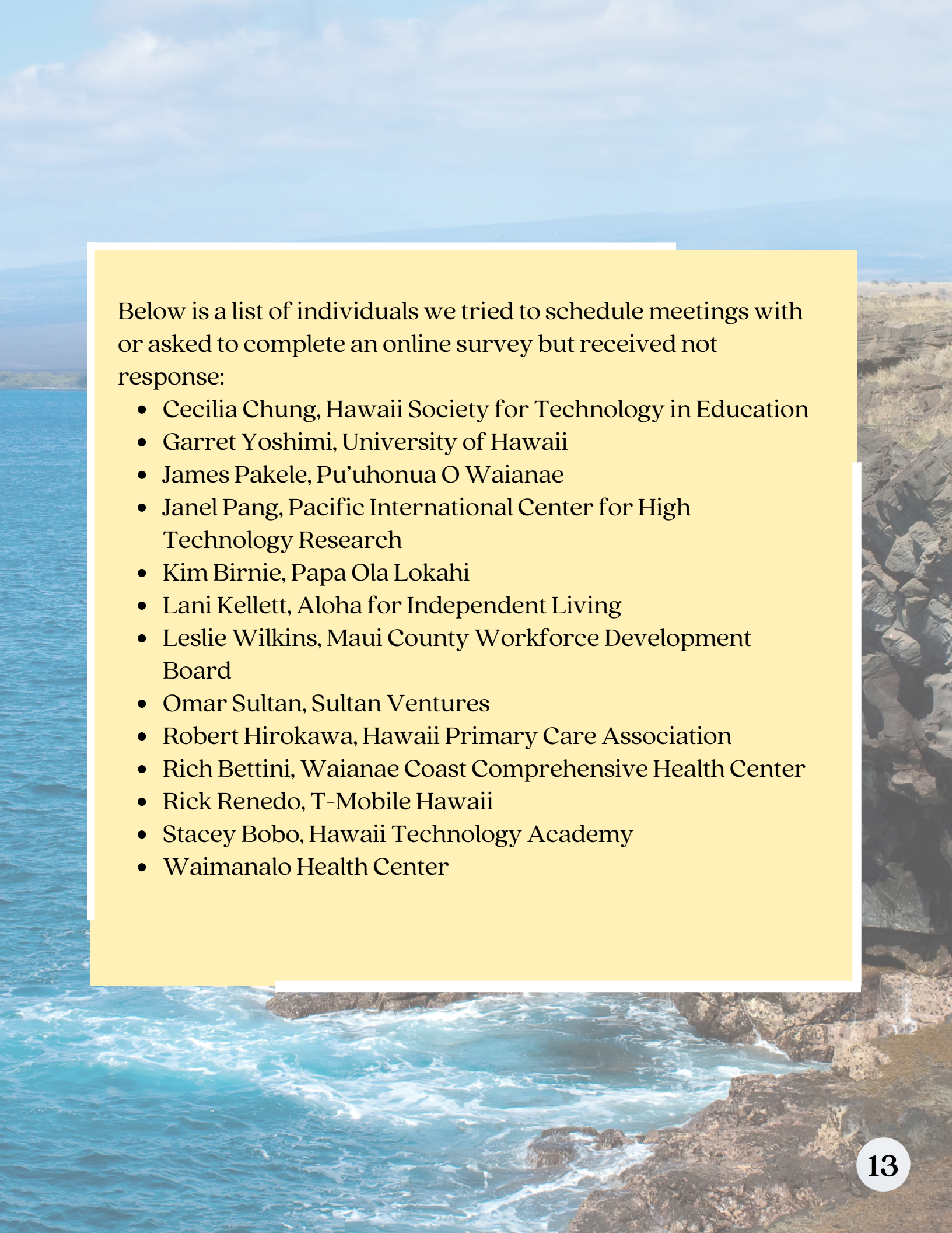
